There is ongoing Court action on our behalf & the ANZ, the person who fraudulently acquired the loan with ANZ & their two staff members.

In September 2018 the Police began assisting two people to get us off the property, their unlawful behaviour has escalated supported by Victoria Police with our title attempting to be transferred ten

times & then cancelled in October 2018.

The titles office states it's a glitch in their system.

In December 2018 myself and my sister in law were in fear for our life on our Property and secured ourselves in our home which led to this person assisted by twelve police on the day breaking into the building and violently assaulting us (myself 59 yrs & my sister in law 52 yrs, that were never a threat to anyone) arresting us on false charges for trespassing on our own property and being released on bail.

We are looking over our shoulders all the time wondering what they will do next.

How My Life Has Been Affected:

Our business has been extremely effected financially our health has been impacted greatly it consumes our lives just retaining possession of our property financially exhausted from legal costs the impact on physical, mental & emotional health is enormous, not only personally on extended family and friends as well.
